## What is child sexual abuse?



**Child sexual abuse** is when a person younger than 18 is included in sexual acts that they:

- don't agree to do
- don't want to do
- are too young to understand.



Child sexual abuse is:


- a crime
- never the child's fault.

## What is the National Redress Scheme?



The National Redress Scheme is for people who have experienced child sexual abuse by a person who worked for an **institution**.

We call it the Redress Scheme.





- by the government
- for a religion
- for education
- to run a business
- to help people.



Examples of institutions include:

- schools
- churches and religious groups
- scouts and guides
- sports clubs
- child care services
- orphanages and foster care.



Over the past few years, there was a Royal Commission into child sexual abuse in institutions.



This was a large and formal investigation that looked into what happened to children who were abused.



The Royal Commission said that the government should set up the Redress Scheme.




**30 June** 2028

The Redress Scheme:

- started on 1 July 2018
- will end on 30 June 2028.





- as a child and
- by a person who worked at an institution or organisation



The Redress Scheme can only help you if the institution where the abuse happened has joined the Redress Scheme.



Institutions that have joined the Redress Scheme include:

- state and territory governments
- the Catholic church
- the Anglican church
- the Uniting church
- Scouts
- Salvation Army
- YMCA.

## What does the Redress Scheme offer?



**Redress** is a way of trying to make things right.

The Redress Scheme can offer you 3 things:



- Counselling and psychological care where you can:
  - talk to someone about how you think
     and feel
  - o find out ways to help you feel better.



• A payment of up to \$150,000. But most people who get a payment are given about \$76,000.



 The institution where the abuse happened will contact you.



They may apologise and will:

- accept that the child sexual abuse happened
- say how they will stop it in the future.



You can choose one or all 3 of these things.

### How does the Redress Scheme work?

To get help from the Redress Scheme, you will need to apply.



You must be:

- an Australian citizen
- a permanent resident.



The child sexual abuse must have happened before:

- you turned 18
- 1 July 2018 when the Redress Scheme started.



You can still apply for the Redress Scheme if you are under 18 with the help of your parent or carer.



But you need to turn 18 before the Redress Scheme ends in 2028.

 financial services – someone who can help you with your money if you get a payment.
